- (c) information that would, if disclosed, confer a commercial advantage on a person with whom the council is conducting (or proposes to conduct) business
- (d) commercial information of a confidential nature that would, if disclosed:
 - I. prejudice the commercial position of the person who supplied it, or
 - II. confer a commercial advantage on a competitor of the council, or
 - III. reveal a trade secret
- (e) information that would, if disclosed, prejudice the maintenance of the law
- (f) matters affecting the security of the council, councillors, council staff or council property
- (g) advice concerning litigation, or advice that would otherwise be privileged from production in legal proceedings on the grounds of legal professional privilege information concerning the nature and location of a place or an item of Aboriginal significance on community land.

SUMMARY

To advise of the 2019 Local Government Aboriginal Network Strategic Planning Conference and consider attendance.

Advice has been received that the 2019 Local Government Aboriginal Network Strategic Planning Conference will be held in Sydney from Wednesday, 9 Oct 2019 (8:00 AM) until Friday, 11 Oct 2019 (1:00 PM). Cr Naden has expressed an interest in attending this year's conference.

This year's conference has a Strategic Planning format, different to the usual Local Government Aboriginal Network conferences. The focus of this forum is to connect and plan LGAN for the next 30 years starting with the lead up to the next LGAN conference to be hosted by the City of Sydney in 2020.

The NSW Local Government Aboriginal Network's Terms of Reference include the following objectives:

- To provide understanding of current issues in Local Government that directly affects Aboriginal Peoples and Communities.
- To maintain a mechanism for support of Aboriginal Staff and Councillors in Local Government and all those involved in Aboriginal affairs that deal with Local Government.
- To promote Reconciliation between Aboriginal & non-Aboriginal NSW Residents.
- To advocate that Aboriginal values and practice become part of mainstream Government policies, programs, practice and Community life.
- To promote and create a venue for information exchange on existing and/or new programs and services within Local Government by the way of an annual conference.

Cr Naden attended last year's conference in Narrabri and has indicated she would like to attend this conference. Other Councillors may also wish to attend. Cost of attendance is \$496.94 per person for the full conference.
