# Gilgandra Shire Council Local Heritage Fund guidelines

#### 1 Local Heritage Fund purpose

The Gilgandra Shire Local Heritage Fund has been established to assist owners of places with heritage significance undertake conservation and restoration works. Items of heritage significance include buildings/structures/sites identified as contributing to the character of the Gilgandra Heritage Conservation Area (if needed, please seek clarification of the location of the Heritage Conservation Area from Council) and items included on the Gilgandra Community Based Heritage Study (please see <a href="http://www.gilgandra.nsw.gov.au/Enjoy/Cultural-Heritage/Heritage-management">http://www.gilgandra.nsw.gov.au/Enjoy/Cultural-Heritage/Heritage-management</a> to download a copy of the study which lists all 97 local heritage sites in Gilgandra).

Examples of the type of work that can be funded under this program may include, but are not limited to:

- Painting in approved heritage colour schemes
- Repairs to stumps, walls, roofs, doors, floors, and windows
- Replacement of guttering and down pipes
- Reinstating missing components, including verandahs and awnings
- Repairs to awnings on public and private buildings
- Meeting Building Code of Australia requirements (eg. fire regulations and disability access)
- Engineering reports on the structural integrity of a building (including awnings, verandahs and balconies)
- Readaptation or reuse of a heritage building

The aim is to maintain, preserve or restore elements that contribute to the heritage value of a place. The funding cannot be used for improvements such as new kitchens or bathrooms (in private residences, however may be considered if these facilities will be available for public use). Council's Heritage Advisor will assess all projects submitted for the Local Heritage Fund project and provide free advice to the successful applicants on their proposed work.

#### Projects funded through the local heritage fund

In the past Council offered assistance with the following types of projects:

- Repair sash & casement windows
- Replace flooring (generally in public buildings, unless an exterior verandah in a private home that is visible from the street)
- Replace roof sheeting
- Replace guttering & downpipes
- Professional engineering reports addressing building safety concerns (awning, fire safety, accessibility).
- Re-stumping of buildings
- Repainting in heritage colours
- Widening of entry doors to public buildings for accessibility
- Upgrades to buildings in relation to fire regulations







#### 2 Type of funding available

Where grants are approved, they are usually on a dollar for dollar basis. There is a limit of \$2,000.00 provided by Council, to match a similar (or greater) contribution from the owner. This may vary depending on the number of applications received. Council will consider applications where the owner's contribution is in the form of labour and/or materials rather than cash. Please note that grants are not made in respect of properties on which rates are unpaid.

# 3 Closing dates for applying for grants from the Local Heritage Fund

Applications for funding under this program must be submitted to Council before 5pm on Monday 16 August 2021.

#### 4 Who can apply for grants from the local heritage fund?

The following people may apply for funding under this program:

- Owners of places listed on the Gilgandra Shire Council Local Environmental Plan Schedule 5 Heritage items (see www.legislation.nsw.gov.au/#/view/EPI/2011/641/historical2016-01-27/id79).
- Owners of buildings identified as contributing to the character of the Gilgandra Heritage Conservation Area. More information about these the Heritage Conservation Area can be obtained by contacting Council's Heritage Advisor (see details below).
- Owners of other places identified as having cultural heritage significance. You can call Councils Heritage Advisor (see details below) to discuss accessing the Local Heritage Fund for your project.

Government agencies cannot apply for funding under this program, but may be involved as a project partner.

# 5 What projects cannot be funded by the local heritage fund?

Assistance will not be provided from the Local Heritage Fund for the following types of projects:

- New buildings
- Routine maintenance, e.g. lawn mowing, gutter cleaning or carpet cleaning
- Projects where adequate funding is available from the applicant or other sources
- New commemorative monuments or works
- The purchase of heritage buildings
- The relocation of buildings or works to relocate buildings
- Private headstones, unless there is no possibility of descendent support
- Floodlighting of heritage buildings
- The purchase of equipment
- Moveable railway heritage items
- Advertising signage

#### 6 Agreed funding priorities

Priority will be given to projects that are:

- For heritage buildings/structures/sites in a heritage streetscape or landscape setting
- For urgent maintenance works to avert management risks, e.g. severe deterioration, demolition, or demolition by neglect
- For items that are part of an identified heritage group or a precinct
- Fire, service and access upgrades for compliance with the Building Code of Australia
- Projects relating to awnings, verandahs or balconies on heritage buildings/structures
- For ongoing or adaptive reuse of heritage buildings/structures/sites
- Continued public access to heritage buildings in our Shire.

#### 7 Common selection criteria

Funding is targeted to projects:

- With sustainable long-term heritage benefits
- That are for public benefit and enjoyment
- That show innovation and creativity
- Where the project partners/applicant(s) have the capacity and commitment to undertake the project
- That demonstrates funding equity and cost effectiveness

### 8 Applying for funding

To apply for funding for a project from the council's local heritage fund:

- Read the application form so you know what information you need and if your project fits the types of funding offered
- Speak with the Gilgandra Shire Council staff (preferably the Heritage Advisor) about your project.
- Do some background research on your heritage item so you can include all relevant information in your project proposal (attach any relevant information quotes, photos, historic records, relevant plans and sketches, any other approvals required)
- Prepare a list of project tasks to be completed
- Obtain quotes for each of the projects tasks
- Complete the application form, submit to Council before the closing date, and keep a copy for your records

## 9 Submitting your application

#### 10 Processing your project application

Projects will be assessed and approved by Gilgandra Shire Council. In assessing your application, the quality and clarity of information provided will be taken into account. Council's Heritage Advisor will be working on the assessment of applications in August/September 2021 and the process will include a site visit. Council's Heritage Advisor will be in contact with you directly to arrange an appointment with you as part of the assessment process.

A funding offer and contract will be sent to successful applicants once the inspection and assessment is completed by the Heritage Advisor. These papers will need to be completed, signed and returned to Council as soon as possible. Those applicants that do not return the offer and contract documents complete within 28 days of receiving them will be withdrawn from the Local Heritage Fund for this round.

On acceptance of this offer, projects can commence immediately and must be completed and all relevant paperwork (e.g. invoices to Council) submitted to Council by 5pm Monday 11 April 2022 for payment processing. It anticipated that funding will be reimbursement to successful projects before end of financial year 2021, depending on receipt of a correct invoice from applicants.

Gilgandra Shire Council will advise unsuccessful applicants, once site inspections have been completed and the final assessment done by the Heritage advisor.

The Gilgandra Shire Council Local Heritage Fund is a targeted funding program. Projects must meet eligibility criteria, funding priorities and common selection criteria. However, in exceptional circumstances, Council reserves the right to recommend funding for projects that may not fully meet these requirements.
