

In 2021, Gilgandra Shire Council has announced there is \$10,000 in Cooee Cash to be won through the Shop Local Christmas and Customer Experience Feedback draws.

Promotion Rules 2021:

Shop Local Christmas Draws

Entrants must collect receipts from businesses registered or operated in the Gilgandra Local Government Area (from here forward to be referred to as "Participating Businesses") between 8am 1 November 2021 and 9.59am 23 December 2021.

- When entrants have valid receipts to the minimum value of \$20 with receipts from participating businesses, they must
 - Place these in the official entry envelope and place in the entry barrel located on Miller Street; or
 - Submit an entry electronically via the form on the Gilgandra Shire Council Website, gilgandra.nsw.gov.au. This form will include the upload of a digital copy or photo of the eligible receipt/s.
- Receipt/s in a single entry can be of any value and any participating business so long as the receipts in the official entry total a minimum of \$20.
- The promotion runs from 8am on Monday, 1 November 2021 until 9.59am on Thursday, 23 December 2021.
- There is no minimum age for entry in the promotion. However, if the winner is under the age of 18 years the prize will be awarded to the parent or legal guardian.
- Only original receipts will be accepted or authorised and validated copies or vouchers where the receipt needs to be retained for warranty, business or taxation purposes. Copies or vouchers must be signed or stamped by relevant participating businesses to be eligible.
- All entries must be placed in the official entry barrel or submitted electronically via the Gilgandra Shire Council Website, gilgandra.nsw.gov.au, by 9:59am prior to the draws taking place.
- The business winner for each week will be randomly selected from the receipts submitted with the online entries via an electronic random selector tool.
- A participating business can only win once in the business draws during the promotional period.
- An individual can only win once per weekly draw.
- Weekly winners will be drawn from the digital pool and physical envelope pool in separate draws.
- The physical draws will take place at 10am on the following dates out the front of the GIL Collective and Visitor Information Centre, 30-32 Miller St, Gilgandra NSW 2827.

The electronic draws will take place at 10am on the following dates and will be live streamed via the Gilgandra Shire Council Facebook Page.

- Thursday, 2 December 2021 – 1 Draw of \$1000 for individuals; 1 Draw of \$500 for businesses.
- Thursday, 9 December 2021 – 1 Draw of \$1000 for individuals; 1 Draw of \$500 for businesses.
- Thursday, 16 December 2021 – 1 Draw of \$1000 for individuals; 1 Draw of \$500 for businesses.
- Thursday, 23 December 2021 – 1 Major Draw of \$2000 for individuals; 1 Draw of \$500 for businesses.

- Winners will be notified via phone contact numbers supplied on the entry envelope or online form, after the draw has taken place.

 - The online submissions via an electronic random selector tool. The draw will be live streamed on the Gilgandra Shire Councils Facebook page.
- The entries drawn will be validated and checked to ensure they meet the criteria listed above. An entry will not be deemed the winner unless it meets the criteria for entry. In the event the entry is not deemed valid, there will be a redraw. This process will continue until a winner is found.

- Coo-ee Cash Cards are not transferable for Australian currency or any other financial product or currency that can be converted to cash.
- The barrel will be emptied of all entries and the online draw reset after each weekly draw has taken place.
